Committee members felt that they already implement many of the TILT recommendations and the common language TILT provides is helpful. Would like to see more deliberate framing of how equity needs to be considered in the assessment of student learning. The TILT process is appreciated for its evidence-based simplicity.

 - 1. We need to know where the learning for *Personal, Professional and Community Responsibility* is happening.
