Membership Eligibility and Academic Release Agreement

...[T]he Union of Students of the University of Alaska Anchorage represent all student interests, needs, and welfare within the university community, to supplement and complement education on the University of Alaska Anchorage campus; to provide for the expression of student opinion and interests to the community at large; to protect the rights of the students herein stated; and to promote an understanding of the concept of self-governance...

Article Five, Clauses 1-4 of the Constitution of the Union of Students of the University of Alaska Anchorage states the following:

All USUAA office holders, petitioners, and candidates must be members of USUAA, have and maintain a minimum cumulative G.P.A. at UAA of 2.5 (on a scale of 4.0) and complete at least three credit hours per semester. Students must also be in good disciplinary standing with the University. Students wishing to fill an USUAA office who do not have an established G.P.A. at UAA will have a probationary status. After completion of their first semester, they must meet the above requirements.

Failure to maintain these academic standards may result in an academic review by the Rules Committee and the Assistant Director of Student Leadership.

This review may result in either of the following:

Dismissal from the Assembly.

Academic Probation, defined as entrance into an academic performance agreement with the Assistant Director of Student Leadership within five (5) working days after the academic review.

Any Assembly member, whose cumulative G.P.A. falls below 2.0 will not be eligible for probation.

Assembly members can be granted only one (1) probationary period limited to one (1) semester.
