The AAC complimented the outcomes and measures, and suggested they consider a measure capturing student performance in a key class or assignment.

 Computer Networking Technology AAS & CISCO Certified Associate OEC (Plan Pgs. 64-72, Related Curriculum: AAS, OEC)

The AAC recommended approval for this plan. The plan must be updated in AY19 to more fully address related instruction for the AAS.

• Diesel Power Technology AAS/UC – Last AAC review 4/15/16 (Plan Pgs. 73-78, Related Curriculum: AAS, UC)

The AAC recommended approval for this plan. The plan must be updated in AY19 to more fully address related instruction for the AAS.

• Early Childhood Special Education MEd (Plan Pgs. 79-114, Related Curriculum: MEd)

The AAC recommended that this plan be updated and resubmitted to reflect the program's current standards in AY19.

• Fire and Emergency Services Technology AAS – Last AAC review 4/19/13 (Plan Pgs. 115-128, Related Curriculum: AAS)

The AAC recommended approval for this plan. The plan must be updated in AY19 to more fully address related instruction, and should be proofread during those revisions. The Committee noted the plan was otherwise detailed and well done.

• Physical Education BS (Plan Pgs. 195-211, Related Curriculum: BS)

The AAC recommended the plan be updated in the Fall to more closely connect the measures with the program student learning outcomes.

• Political Science BA (Plan Pgs. 212-255, Related Curriculum: BA)

The AAC recommended approval for this plan. The committee will send suggestions to the program faculty for possible future plan updates: considering rotating measures on a cycle rather than assessing eight annually; and updating dates to reflect the most recent review, with an introduction section indicating recent discussions and revisions.
