Given the assessment reporting hiatus due to the expedited program review requirement, the deans and the AAC recommended a note be added to the Annual Academic Assessment Survey reminding assessment coordinators that submitting Annual Assessment Reports will not be mandatory for this academic year, but that assessment practices are still important to keep on track.

Another suggestion was to highlight the importance of completing questions 14-20 on the survey. There were no suggestions for removing or adding any questions to the survey.

• Annual Academic Assessment Retreat, Thursday, May 7 in LIB 307 (tent.)

At the 2019 Seminar, there was interest in additional training. The committee and deans suggested focusing the retreat on assessment training, featuring model programs talking about their processes and/or the positive program changes made based on assessment data/results. Training could include vocabulary, to insure consistency across the institution.

Deans were asked and agreed to provide examples in the future of exemplary Assessment Reports so Academic Affairs can highlight them, which could help develop assessment mentorships. These programs could potentially be asked to present at the retreat.

The AAC encouraged deans to refer assessment plans with issues to the committee (through OAA), so they can help programs develop better plans and reports, or provide a connection to mentors. The deans agreed with this suggestion.
