A. GER Policy- Language from Suzanne

Catalog pg 58

Last paragraph under both "Certificates and Associate's Degrees" and "Baccalaureate Degrees" could be changed to:

If the requirements for a <certificate or associate's / baccalaureate degree> as specified in the entry-level catalog are not met within seven years of formal acceptance into the program, admissions expires and the student must reapply for admission and meet the current admission and graduation requirements in effect at the time of readmission or graduation, the only exception being is that a UAA course that satisfied a GER requirement during the semester it was taken will continue to satisfy that GER requirement regardless of whether its status has changed in the catalog under which the student will graduate.

Catalog pg 80

General Education Classification List

Revised language from Suzanne:

A course that satisfied a particular GER requirement in the semester the student completed it will satisfy the expected GER requirement for that student even if its GER status has changed in the catalog under which the student graduates.
