All classes set-up with Pearson will automatically provide access to enrolled students. If the student does not want the digital version, they will need to opt out. Should they not opt out, the bookstore will bill them right after the drop/add class deadline. There are other contracts in place with other publishers as well like McGraw-Hill.
