

Psychological Services Center Fees, Sliding Fee Scale, and Good Faith Estimate

Although we are committed to providing high quality clinical services, the clinic's primary purpose is clinical training; therefore fees are modest and adjustable. The fees we charge are used to operate the Psychological Services Center and advance the training of student clinicians. Our services have a set session fee based on community standards. While the fees are set, we offer a sliding fee scale that may reduce the amount you pay. You may be eligible for a fee discount based on household size and income and any unusual circumstances. If you wish to apply for the sliding fee scale, you can complete the Financial Form. Please let us know of any significant change in your financial status. You can request a review at any time if you feel you need a fee adjustment.

Good Faith Estimate

Following being accepted for services, we will discuss fees with you and discuss the cost of care, including providing you with an estimate of the cost of services. **All clients are entitled to a Good Faith Estimate that will be given in writing and verbally upon request.**

Screening/Group: no cost

Psychotherapy, Individual/Family/Couples: \$89

Assessment: \$500*

Consultation/Legal Fees: \$89 per hour
