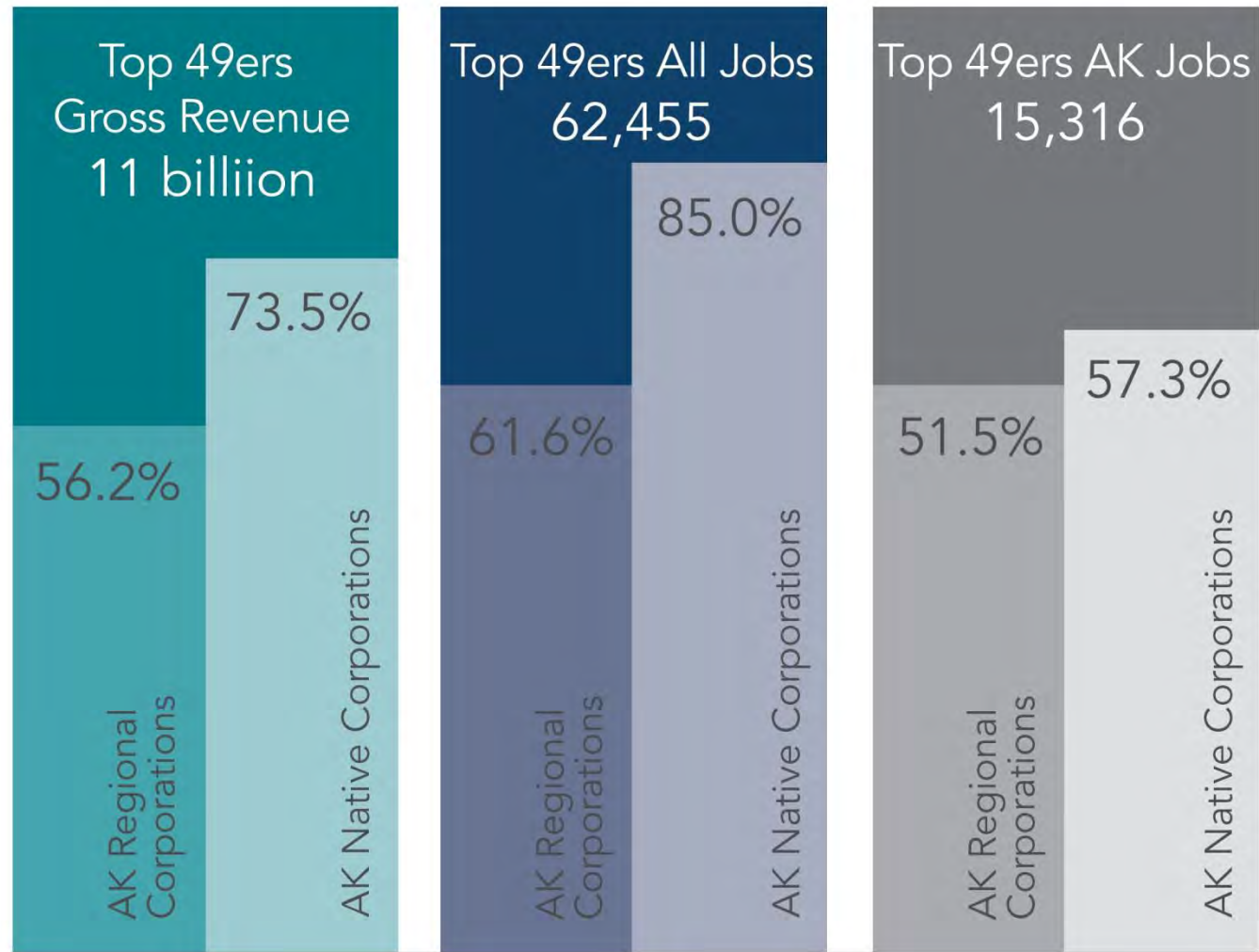

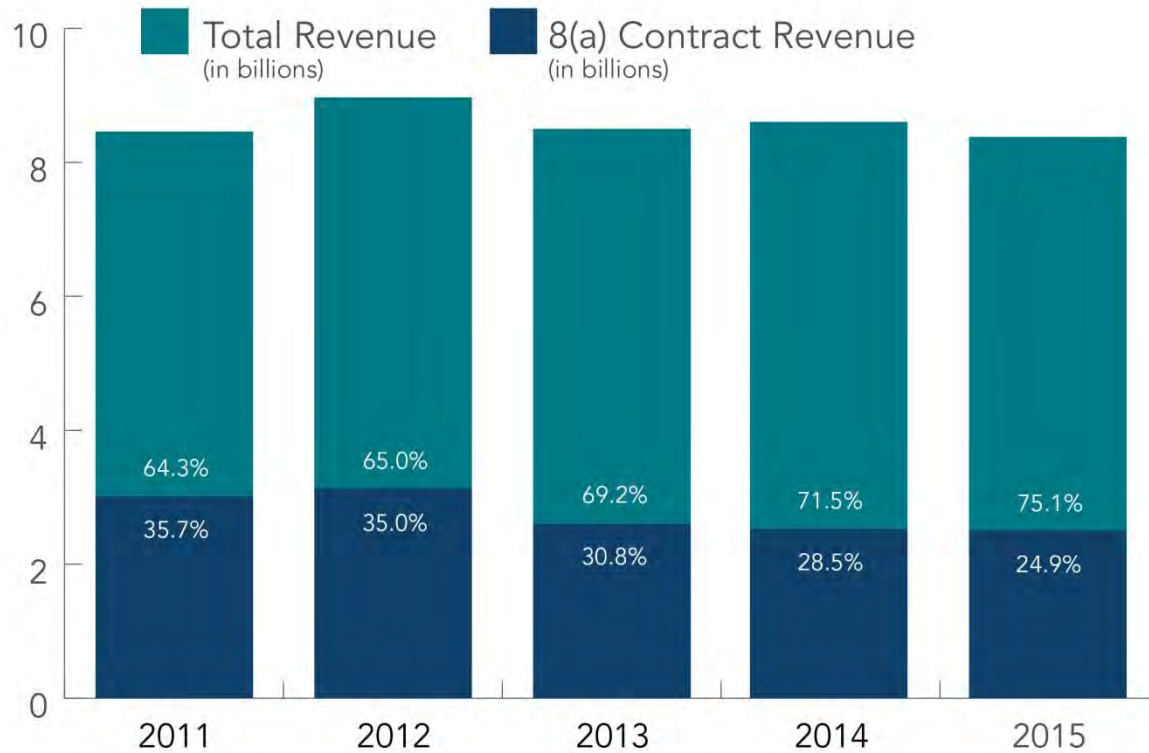


IMPACT OF ANCSA CORPS

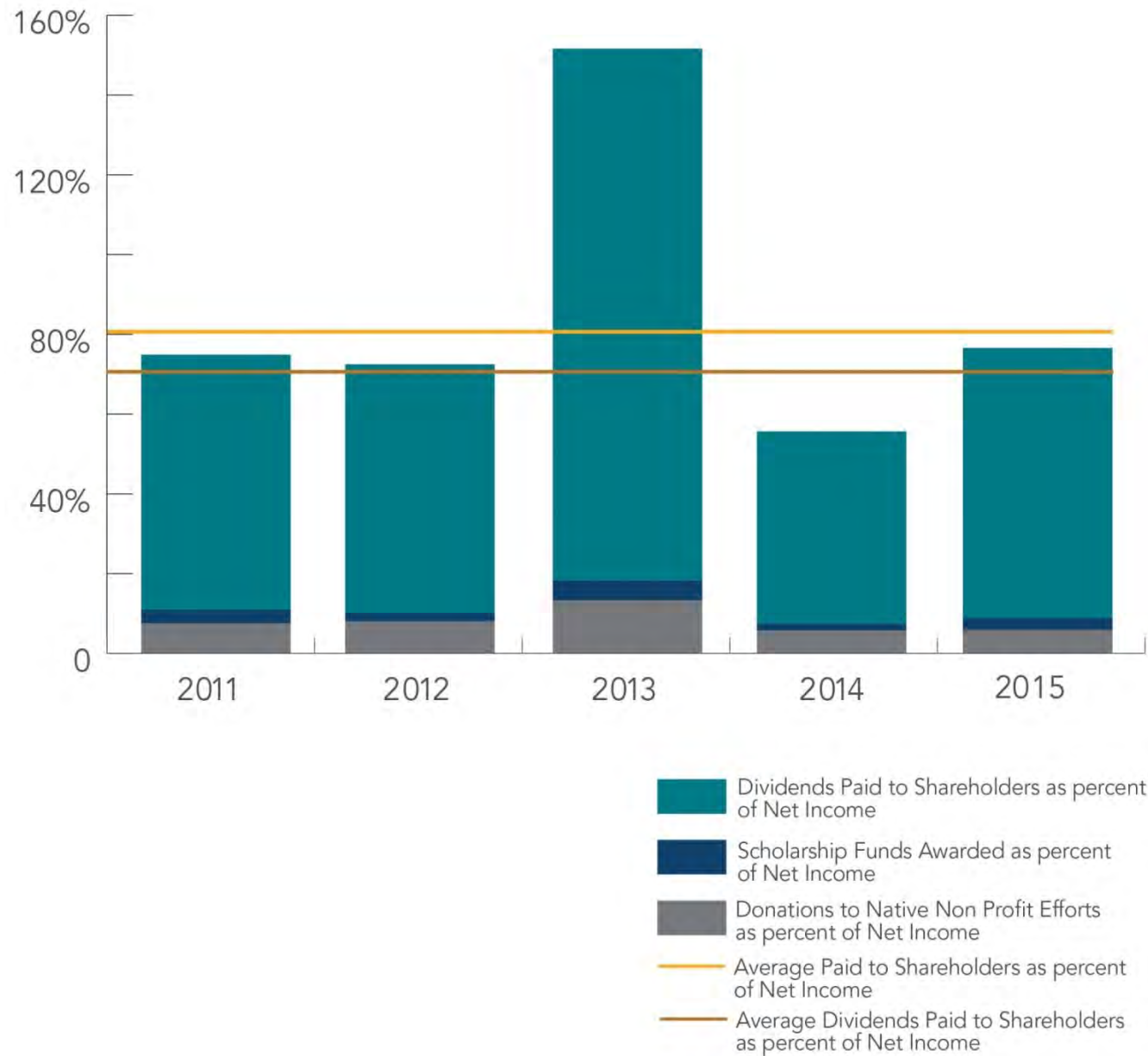

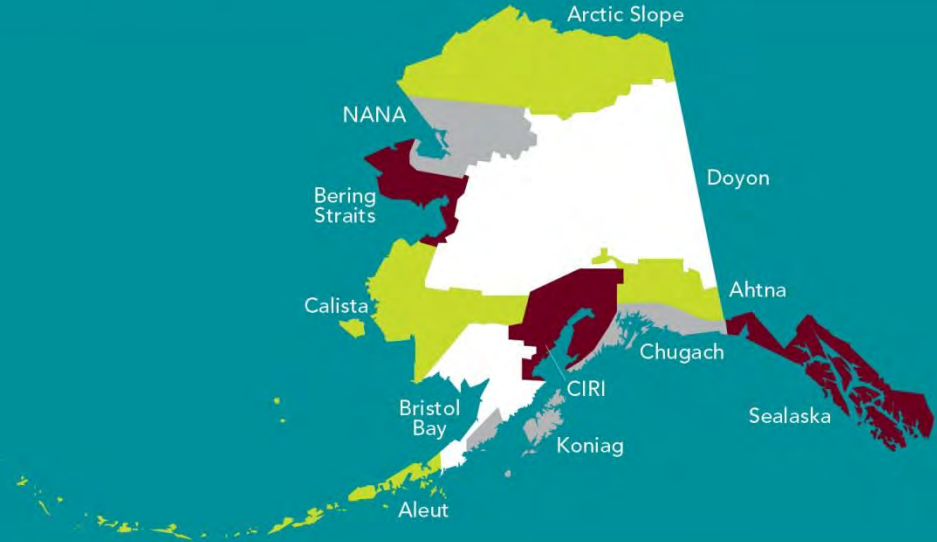
