Outcome measures of a student's ethical awareness and consideration are evaluated through their Knowledge of Ethical Considerations and Responsibilities and Demonstration of Ethical Practice in Research.

Knowledge of Ethical Considerations and Responsibilities - three students in the program are completing their coursework. They took ANTH A658 - Advanced Ethics in Archaeology, which provides direct training of professional ethics. Other courses that include ethics training are ANTH A615

Advanced Applied Anthropology, ANTH 687 - Field Methods in Cultural Anthropology, and ANTH A610 Anthropological theory. Assessment data came from the grades of their professors based on their performance in the courses.

Demonstration of Ethical Practice in Research - A demonstration of ethical practice in research comes through the student's prospectus, their oral defense, and completed thesis at the end of the program. Two students defended archaeological theses in Academic Year 2022-2023, providing assessment data.

These assessments begin during the coursework phase of their program, and continue through the final thesis.

3. What are the findings and what do they tell the faculty about student learning in your program? (1000 words or less)

The students all earned As or Bs in their coursework, meeting faculty expectations.

Both students who defended their theses acknowledged the contributions of their employers, collaborators, outside funding sources, and Indigenous groups associated with the areas they worked in, demonstrating their awareness of the multiple facets of ethical responsibilities in the profession, thereby meeting faculty expectations.

The program intentionally inserted courses on ethical practices with program changes initiated in 2018-2019. On the recommendation of our students, ethical issues and practices were included as part of the content in other applied courses including theory, applied anthropology, and field methods.

Last year there were only two anthropologists in the department. In the past year we hired two additional anthropologists - an archaeologist and a bioarcheologist. Both have excellent records in professional ethics and will add to the program.

Our evidence is primarily from students' actions once they leave the university, and their concern with ethical practices in their jobs. Based on performance there appears to be a shift from our earliest graduates and our most recent graduates. Students are more likely now to contact us about ethical dilemmas than in the past. This may be partly owning to our increasing emphasis in classes and by interacting with the students more informally. These data are subjective.
