The keynote speaker, Dr. Suzanne Tapp, will present ideas on how to modify assignments using TILT (Transparency in Learning and Teaching) to increase student understanding of the learning objective(s) in curricular and co-curricular activities. The examples shared at the open forum will focus on the Personal, Professional and Community Responsibility core competency as the start of the implementation of the pilot project. Provost Runge suggested using her blog to promote attendance at the open forum.

Dr. Jen Stone is the first member of the writing team being developed for the accreditation process. The report will showcase two programs that are good examples of completing the assessment of student learning process. Program suggestions are being solicited.

The next steps for the fall semester include an institution-wide survey of how the Personal, Professional and Community Responsibility student learning is already being addressed in curricular and co-curricular student learning activities, a series of open forums, and mapping the pilot core competency student learning opportunities throughout the institution.

b. Student Achievement Metrics Working Group

The group is developing a recommended process to identify student participation in high impact practices within Banner. They are working to determine what student success programs are, establish

criteria to define participation in these programs, develop an attribute code to identify participation in the programs, and create an assessment program to evaluate key indicators of student success within the program participants.

As AY21 NWCCU Mission Fulfillment Fellows, virtual visits to peer institutions will be completed in September to learn more about national best practices for implementing core competencies for student learning across an institution.

f. AY20-21 Retention, Completion, and Student Success Academy (Claudia Lampman)

Work is continuing with the submission of writing samples to evaluate student placement in writing (WRTG) courses in addition to Accuplacer scores, which is resulting in higher course placements and higher pass rates. In addition to improved success rates, this has resulted in approximately \$250,000 in tuition savings for the 400 students who participated.
